The laws of the State of Colorado shall govern this Agreement. Any provisions hereof which may prove unenforceable under any law shall not affect the validity of any provision.

The failure of the Seller to insist on the performance of any of the terms, or to exercise any right or privilege or its waiver of any breaches shall not thereafter waive any other breach or waive any such terms, conditions or rights to privileges it might have thereunder.
